- 3. Short Form Final Plat: Rudder Lane.
 - Mr. Mark Rendon of Stellar Homes, on behalf of Cory and Heather Self, has submitted a request for a Short Form Final Plat to replat 0.511 acres. Mr. and Mrs. Self desire to combine four lots into one for future home construction. These parcels are located at the intersection of Aquatic Drive and Rudder Lane. **NO** action is necessary.
- Short Form Final Plat: Rancho Del Lago, Phase III.
 Mr. Jason Carothers, on behalf of Quadruple Bogey Development, Inc. has submitted a request to replat two lots
 - (Block 6, Lots 8, .78 acres, and Tract A 5.4 acres) located in the Rancho Del Lago subdivision with a combined area of 6.18 acres. The proposal will create two new lots (Lot 8-A, 1.21 acres, and Tract A-1, 4.97 acres.) These parcels are located on Cedro Circle. **NO** action is necessary.

- 7. Discuss and consider Resolution 2017-10: Short Form Final Plat: Rudder Lane.
 - Mr. Mark Rendon of Stellar Homes, on behalf of Cory and Heather Self, has submitted a request for a Short Form Final Plat to replat 0.511 acres, more or less, of land as described above. These parcels are located at the intersection of Aquatic Drive and Rudder Lane. The Zoning Commission recommends approval of the request. A **MOTION** is necessary to act on Resolution 2017-10: Rudder Lane Short Form Final Plat.
- 8. Discuss and consider Resolution 2017-11: Short Form Final Plat: Rancho Del Lago, Phase III.

 Mr. Jason Carothers, on behalf of Quadruple Bogey Development, Inc. has submitted a request to replat two lots (Block 6, Lots 8, .78 acres, and Tract A 5.4 acres) located in the Rancho Del Lago subdivision with a combined area of 6.18 acres. The proposal will create two new lots (Lot 8-A, 1.21 acres, and Tract A-1, 4.97 acres.) This 6.18-acre parcel is situated in the H. KATTERHORN SURVEY, ABSTRACT 505, Bell County, Texas, and being part of the Rancho Del Lago Subdivision. These parcels are located on Cedro Circle. The Zoning Commission recommends approval of the request. A MOTION is necessary to act on Resolution 2017-11.
- 9. Discuss and consider Resolution 2017-12: Short Form Final Plat: Robinson Addition. Mr. Buddy Robinson has submitted a request for a Short Form Final Plat to replat a 0.718 acre parcel of land as described above. These properties are located on Bluebonnet Drive. The Zoning Commission recommends that the request be approved. A MOTION is necessary to act on Resolution 217-12.
- 10. Discuss and consider Resolution 2017-13: Action on award of bid 10" water line extension to Camp Kachina. The 2016/2017 Water Department budget included \$400,000 dollars for an extension of a 10" water line running parallel to Morgan's Point Road from Clearwater Drive to Camp Kachina Road. Bids were opened on April 12,

- 2017, with Bruce Flanigan Construction, Inc. submitting the low bid of \$206,206.50 dollars. A **MOTION** is necessary to act on Resolution 2017-13.
- 11. Discuss and consider Resolution 2017-14: Capital Improvement Program budget amendment-Marina roof extension. The current marina rehabilitation project includes refloating "B" Dock and covering four, 26' slips on "A" Dock. Marine Development Inc., of Eufaula, Oklahoma has provided pricing to increase the size of the 26' slips to 30' and expand the 26' roofs to 30 '. A **MOTION** is necessary to act on Resolution 2017-14.
- 12. Discuss and consider Resolution 2017-15: Capital Improvement Program water storage and pumping equipment. The 2016/2017 Water Department budget included \$991,000 dollars for the construction of a ground storage tank, pumping station, and other assorted system improvements. Bids for the project were opened on May 2 with Emerson Construction Company, Inc., being the low bidder at \$1,015,350 dollars. A **MOTION** is necessary to act on Resolution 2017-15.
- 13. Discuss and consider action on Memorandum of Agreement: Emergency Medical Task Force ("EMTF".)

 Fire Chief John Phillips has submitted information regarding an Emergency Medical Task Force that could benefit the City of Morgan's Point Resort in the event of a major emergency or catastrophe. A **MOTION** is necessary to authorize execution of the Memorandum of Agreement.
