

Dear Local Business Owner/Operator,

The City of Morgan's Point Resort has been allocated certain relief funds from the CARES Act to be used to mitigate the costs incurred as a result of COVID 19.

As a part of relief funding, the City Council has approved a grant for our local businesses. Each qualified business is eligible to receive a \$500 grant to offset the cost of personal protective gear, additional cleaning and disinfectant and other COVID related costs. This is a lump sum grant of \$500 and the only requirement is to complete a simple, one page application.

Eligibility Criteria:

- Must be locally owned, independent business
- Must have a physical and publicly accessible location within Morgan's Point Resort within a commercial building or business district

Ineligible Businesses

- Nonprofits, sexually oriented business, lobbying organizations, political organizations, gambling businesses, and home-based businesses.
